

User License Agreement for TanDEM-X Sample Data

User License Agreement for TanDEM-X Sample Data for Scientific Evaluation Purpose Only

The following User License Agreement applies to the TanDEM-X Sample DEM (Digital Elevation Model) Data derived from radar data of the TanDEM-X Mission ("DEM DATA"). DLR also provides Meta data (e.g. water mask, height error map, etc.) ("META DATA"). The META DATA together with the DEM DATA resulting into a "DATA SET". DLR permits the use of one copy only of the DATA SET. The copyright and the data themselves remain the property of DLR.

1. By sending the request to receive the DATA SET from DLR the user accepts the subsequent User Licence Agreement.
2. DLR as German Space Agency is the owner of the TanDEM-X satellites. It administers this ownership as trustee for the Federal Republic of Germany.
3. DLR retains the ownership of the DATA SET. A transgression of the rights of use expressly granted hereinafter constitutes a penal relevant violation and will in each case be prosecuted.
4. The DATA SET is made available to the user free of charge and only for non-commercial research and scientific purposes. With acceptance of this User License Agreement the user receives - without the right to grant sublicenses - a non-exclusive, non-transferable right to use the DATA SET for non-commercial research and scientific purposes. Any use of the DATA SET for commercial purposes is strictly forbidden.
5. This single user license grants the right to use one copy of the DATA SET on a single computer, but not more than one access at the same time. A multiuser license is required for costumers with multiple users who desire to use a DATA SET over a network.
6. It is strictly forbidden to make the DATA SET available to third parties, whether free of charge or against payment. The user has to take all necessary and reasonable precautions to prevent that third parties gain access to the DATA SET.
7. In terms of the fact that the DATA SET is made available to the user free of charge and only for non-commercial purposes, guarantee claims no matter of what kind are excluded. In particular it is not warranted that the DATA SET is useful for the application areas desired by the user. The given accuracy specification are statistical values referring to the entire DATA SET. Therefore, local inaccuracies – even significant ones – are possible. There is no warranty assumed for the correctness, usability and completeness of the DATA SET. Finally it is not guaranteed that the DATA SET does not infringe upon third party property rights.
8. For damages of the customer arising by the use of the DATA SET as well as consequential damages or losses through this, DLR is liable only in cases of intended or gross negligent causation of the defect causal for the damage by its employees or statutory agents.
9. When publishing the DATA SET DLR's copyright is to appear as "© DLR <year of reception>". Analyzed information, irrespectively of the form in which it was produced, should include a reference to TanDEM-X as the data source.
10. German law applies to the contractual relationship between DLR and the user concerning the demonstration licence according to these Terms of a Licence. Place of jurisdiction for all disagreements arising out of this contractual relationship shall be Cologne, Germany.
